#### ORDINANCE NO. 762

## AN ORDINANCE AUTHORIZING AND APPROVING THE VILLAGE OF WARRENSBURG, ILLINOIS FORGIVENESS OF THE BALANCE OF THE INTERFUND LOAN BETWEEN THE SEWER FUND AND THE GENERAL FUND

WHEREAS, the Village of Warrensburg, Illinois Board of Trustees ("the Village") did previously authorize and approve various loans from the Sewer Fund to the General Fund to promote financial stability and maintain Village operations; and

WHEREAS, the General Fund has made payments to the Sewer Fund for purposes of repaying the loans; and

WHEREAS, the Village does not expect to repay the balance within the foreseeable future without reducing services to the residents or raising taxes; and

WHEREAS, the Village does not wish to reduce services or increase taxes; and

WHEREAS, the Village has determined it is in the best financial interest of the Village to forgive the remaining loan from the General Fund to the Sewer Fund.

NOW, THEREFORE, IT IS HEREBY ORDAINED BY THE PRESIDENT AND THE TRUSTEES OF THE VILLAGE OF WARRENSBURG, ILLINOIS:

- Section 1: That the remaining loan balance of One Hundred Forty-One Thousand Six Hundred Sixty-Seven Dollars and Seventeen Cents (\$141,667.17) owed by the General Fund to the Sewer Fund be and is hereby forgiven.
- Section 2: That the Finance Committee and the Village Administrative Clerk are authorized and directed to make the necessary adjustments on the financial books and records of the Village to reflect the loan forgiveness.

Section 3: That this ordinance, after its passage and approval, shall be published in pamphlet form and shall be in full force and effect on February 16, 2021, after said publication, in the manner, form, and time as provided by the laws of the State of Illinois.
