AN ORDINANCE

MAKING APPROPRIATIONS FOR THE CORPORATE PURPOSES OF THE VILLAGE OF WARRENSBURG, ILLINOIS, FOR THE FISCAL YEAR COMMENCING ON THE 1st DAY OF MAY, 2021 AND ENDING ON THE 30th DAY OF APRIL, 2022.

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF WARRENSBURG, ILLINOIS:
